ORDER

Though this matter was listed earlier on 25.03.2024, there was no representation for the petitioner. Hence, this petition was directed to be listed under the caption “For Dismissal” on 27.03.2024. Thereafter, when the matter was listed on 30.04.2024, the learned counsel for the petitioner requested for adjournment and this matter was adjourned on 20.06.2024. Again, when the matter was called on 20.06.2024, there was no representation for the petitioner.
