It is the case of the petitioner that a patta has been wrongly issued in the name of the 3rd respondent, in respect of his property viz., S.Nos.227/1F, 227/2 and 228/1B, Mathigiri Village, Hosur Taluk, Krishnagiri District. Based on his representation dated 02.08.2023 in this regard, an enquiry was conducted by the 2nd respondent on 30.10.2023. However, no order has been passed so far. Hence, the present writ petition.
