It is the grievance of the petitioners that though they are patta holders in respect of the lands in S.Nos.4/10, 4/11, 4/19, 4/21, 4/22, 4/23, 4/30, 4/31, 4/32, 4/33, 4/34, 4/35, 4/36 and 4/37, the same was not uploaded in the online. Hence, they seek a direction to the respondents to process their online patta.

5. Learned Government Advocate appearing for the respondents would submit that for processing online patta, necessary fee has to be paid by the petitioners, for which, the learned counsel for the petitioner would submit that the petitioners will pay the requisite fee at the earliest.

6. Hence, let the Revenue authorities concerned upload the patta of the petitioners in online and the said exercise shall be carried out within a period of two months from the date of receipt of a copy of this order.

With the above direction, this writ petition is disposed of. No costs.
