This Criminal Original Petition has been filed seeking to modify the conditions imposed on the petitioner in respect of "the petitioner shall deposit a sum of Rs.10,000/- in Crl.M.P.No.16511 of 2024, dated 26.03.2024 on the file of V Metropolitan Judicial Magistrate, Egmore, Chennai."

2. The learned counsel for the petitioner submitted that the petitioner's wife is a daily coolie worker, therefore, she is not able to deposit of Rs.10,000/- imposed by the trial Court against petitioner. Therefore, the learned Counsel seeks to modify the condition.

"the petitioner shall deposit a sum of Rs.5,000/- [Rupees Five Thousand Only] to the credit of Crime No. 54 of 2024 within a period of two weeks from the date of receipt of a copy of this order; and

In all other respects in Crl.M.P.No.16511 of 2024, dated 26.03.2024 shall remain unaltered."

5. Accordingly, this Criminal Original Petition is ordered.
