COMMON ORDER

These Writ Petitions have been filed for the issuance of a Writ of Mandamus, to direct the respondents 1 to 3 to pass appropriate orders on the representations dated 22.06.2020 and 08.11.2022 made by the petitioner herein within the stipulated time period as may be fixed by this Court.

2. Heard Mr.T.Sundaravadanam, learned counsel for the petitioner, Mr.K.H.Ravikumar, learned Government Advocate for R1 to R4 and Mr.Bala Ramesh, learned counsel for R5.

3. The petitioner has been posted to the fifth respondent Primary Agricultural Cooperative Credit Society at Denkanikottai. The petitioner submits that he is a physically disabled person and there are other Societies of similar nature just nearby to his residence. The petitioner's

request for transfer to some other Societies has not been considered by the respondents. Hence the petitioner is before this Court.

4. The petitioner cannot claim transfer as a matter of right. However, considering the physical condition of the petitioner who is differently-abled, the respondents shall consider and pass orders on the representation of the petitioner in accordance with the feasibility.

5. With the above observations, these Writ Petitions are disposed.
