ORDER

By consent of both sides, this Writ Petition is disposed of at the stage of admission itself.

2. This Writ Petition is filed to direct the respondents 2 and 3 to survey and fix the boundaries of the petitioner's land comprised in Old Survey No.303/00, New Survey No.303/30 measuring an extent of 525 sq.ft., situated at Paruthiputhur Village, Arakkonam Taluk, Ranipet District, by considering the petitioner's representation dated 10.11.2023.

3. Heard the learned counsel for the petitioner, learned Special Government Pleader for the respondents and perused the materials available on record.

4. The grievance of the petitioner is that he has given representation dated 10.11.2023 to survey the property and demarcate its



boundaries in Old Survey No.303/00, New Survey No.303/30 situated at Paruthiputhur Village, Arakkonam Taluk, Ranipet District. However, the same has not been considered by the respondents. Hence, he seeks a direction.

5. Considering the limited nature of the relief sought for in the present Writ Petition, there shall be a direction to the respondents 2 and 3 to consider the petitioner's representation dated 10.11.2023 and pass appropriate orders, for survey of the property and demarcate its boundaries, after giving notice to the neighbouring land owners and any other interested persons, within a period of two months from the date of receipt of a copy of this order.

6. With the above direction, this Writ Petition is disposed of. No costs.
