### **ORDER**

The writ on hand has been instituted to direct the 1<sup>st</sup> respondent to consider the petitioner's representation dated 12.04.2024 to carry out re-totalling of 1<sup>st</sup> and 2<sup>nd</sup> theory papers of Bio-Chemistry.

2. Mr.R.Sathyamoorthy, learned Counsel appearing on behalf of the petitioner would submit that there is a provision for re-totalling. But it is agreed that there is no provision for revaluation.

3. However, Mr.G.Arumugam, learned Standing Counsel appearing on behalf of the 1<sup>st</sup> respondent would submit that there is no provision, even for re-totalling.

4. In the absence of any provision, this Court cannot consider the writ petition. Only if the scheme is available for re-totalling or revaluation of

answer papers, the application submitted by the students/petitioner are to be considered. Therefore, the respondents are directed to verify, whether there is a provision for re-totalling and in the event of any provision, the application submitted by the petitioner is to be considered.

5. Accordingly, the Writ Petition stands **disposed of**. No costs.
