COMMON ORDER

This Writ Petition is filed for a direction to the respondents to extend the benefits of G.O.Ms.No.236, dated 12.07.2018 to the petitioners based on the proposals sent by the third respondent in his proceedings, dated 20.06.2019 on the basis that the petitioners were drawing a scale of pay of Rs.12000-16500 and retired prior to 23.10.2009.

2. When the matter came up for hearing, Mr.R.Venkataramani, the learned Senior Counsel for the petitioner, Mr.U.M.Ravichandran, the Special Government Pleader for the respondent 1 and 3 and Mr.Bindhran, learned Additional Government Pleader for the third respondent are at idem that the matter has already been dealt with by this Court in a batch of Writ Petitions in W.P.No.7905 of 2020 etc., by the order, dated 12.12.2023. As per the said order, the cases have been classified into three types. Similar prayers of the petitioner were categorised as type - II and in respect of type-II, the following relief was granted :-
