Mr.Stalin Abhimanyu, learned Additional Government Pleader accepts notice for R1 and R2 and would submit that based on the advanced intimation of institution of this Writ Petition, R1, Deputy Registrar of Chits, District Registrar Office, Tindivanam has furnished copies of award dated 07.03.2023 in ARC No.71 of 2021.

3. However, Mr.Stalin would submit that necessary charges are yet to be paid by the petitioners in this regard.

4. Hence, the petitioners are directed to remit the charges prior to the next date of hearing and since the awards have been sent on 08.07.2024, they will also confirm receipt of the same.
