- i) the respondents are directed to settle the earned leave surrender amount to the petitioner as per his eligibility in accordance with the rules, within a period of twelve weeks from the date of receipt of a copy of this order along with interest at the rate of 6% per annum from the date on which the amount is due till the date of disbursement;
- ii) if the amount is not disbursed within a period of twelve weeks, thereafter the amount shall be paid with interest at the rate of 12% per annum from the date on which the amount is due till the date of disbursement. No costs.
