ORDER

WEB COPY This writ petition is filed seeking for a writ of mandamus directing the 1st and 3rd respondents to provide duty to the petitioner within any reasonable time.

2. The petitioner is working as a driver in the respondent Corporation. It is seen that he was absent from duty on certain days and therefore, disciplinary proceedings are being proceeded against him for the unauthorized absence. The petitioner was directed to produce certain documents and he made a representation on 03.04.2024 with all the said documents. However, he is not permitted to join duty.

3. When the matter came up for hearing, the same was passed over for the learned Standing Counsel appearing for the respondent Corporation to get instructions.

4. On instructions, the learned Standing Counsel appearing for the respondent Corporation submitted that the disciplinary enquiry against the petitioner is progressing. In spite of specific direction, the petitioner has only produced the fitness certificate and not the other documents.
