This writ petition is filed for a direction to the 9<sup>th</sup> respondent to measure the petitioner's land in Chinna Kalrayanmalai Village in Pethanaickanpalayam Taluk, Salem District, by disposing of the petitioner's representations dated 17.05.2023 and 15.08.2023 within a time stipulated by this court.

2. Heard the learned counsel for the petitioner and the learned Special Government Pleader appearing for the respondents and perused the materials available on record.

3. The case of the petitioner is that the subject property was his ancestral property. It is the grievance of the petitioner that the petitioner has given representations dated 17.05.2003 and 15.08.2023 requesting to re-survey the said property, demarcate its boundaries and to issue patta. However, the same have not been considered by the respondents. Hence, the present Writ Petition.

4. Considering the limited relief sought in this writ petition, the 9<sup>th</sup> respondent is directed to consider the representations of the petitioner
