W.P.No.14175 of 2024 : Writ Petition filed under Article 226 of the Constitution of India praying for issuance of a writ of certiorarified mandamus calling for the records pertaining to the impugned order of the 1st respondent dated 10.05.2024 in Na.Ka.2571/2024/Kalal-1 and quash the same as illegal and unlawful and consequently direct the respondents to permit the functioning of the TASMAC shop No.1903 at Ka.Sa.No. 584/A1D1, Trichy-Coimbatore Main Road, Vellakoil, Gangeyam Taluk, Tiruppur District.
