This Writ Petition has been filed for a direction, directing the respondents 1 and 2 to dispose of the representations submitted by the petitioners dated 11.12.2019 and 02.09.2020.

2. Heard the learned counsel appearing for the petitioners and the learned Standing Counsel appearing for the respondents and perused the materials available on record.

3. It is seen that the petitioners submitted a representation in the year 2019. After a period of five years, the representation submitted by the petitioner cannot be considered.
