ORDER

Challenging the order passed by the learned Principal District Judge, District Co-operative Cases Appellate Tribunal, Krishnagiri, the first respondent herein in C.M.A. No.23 of 2008 dated 26.11.2020, this writ petition has been filed.

2.The Hon'ble Division Bench of this Court has held in the case of **E.S.Sundara Mahalingam v. Special Tribunal for Co-operative Case (District Judge) reported in 2020 (1) CWC 417** that the order passed by the Special Tribunal under Section 152 of the Tamil Nadu Co-operative Societies Act can be challenged by way of filing a Civil Revision Petition under Article 227 of the Constitution of India and the Writ Petition is not maintainable.
