This writ petition has been filed forbearing the respondents 1 to 5 by giving approval to the 8th respondent from putting a lay out by converting the lands situated in S.Nos.14/12A,14/1B, 14/2,14/3,14/4A,14/5A,14/6B,14/7B,14/8 and 14/9 to an extent of 1.21 acres and S.No.14/10 ½ share in well in Mansurapath Village, Chetpattu Taluk, Tiruvannamalai District as house plots, based on the petitioner's representation dated 30.03.2021.

2. On perusal of the records and the submissions made by the 8th respondent, it is seen that on receipt of the objections raised by the petitioner, the first respondent categorically stated that the layout approval cannot be granted for poromboke land and it can only be granted for Nanjai land. The subject matter of this writ petition is a punjai land. That apart, the 8th respondent never presented any layout for approval.
