Having regard to the limited scope of the prayer that is now sought before this Court by the petitioner, without expressing any opinion on the merits of the petitioner's contentions in the affidavit filed in support of the petition, the respondents 1 to 4 are directed to consider the representations of the petitioner dated 20.04.2024 and 24.04.2024 and pass appropriate orders in accordance with law, after holding enquiry and hearing the fifth respondent, within a period of twelve weeks from the date of receipt of a copy of this order. The writ petition stands disposed of. No costs.
