2. Mr.D.B.R.Prabhu, learned Standing Counsel accepts notice for respondents 1 and 2 and Mr.Habeeb Rahman, learned Government Advocate accepts notice for respondents 3 and 4.

3. It is the contention of the petitioner that though he has complied with all the requirements as set out by the respondents herein, the first respondent is not issuing the Trade Licence and therefore, he is unable to peacefully carry on his business.

4. Considering the limited prayer sought for and after hearing the learned Standing Counsel for respondents 1 and 2 and learned Government Advocate for respondents 3 and 4, a direction is issued to the first respondent to consider the petitioner's application for Trade Licence dated 02.04.2024 and pass appropriate orders on merits and in accordance with law, within a period of four weeks from the date of receipt of a copy of this order and issue Trade Licence, if the petitioner has complied with all the requirements. It is needless to state that keeping in view the earlier orders of this Court, the respondents shall not disturb the business of the petitioner.

There shall be no order as to costs. Consequently, the connected Writ Miscellaneous Petition is closed.
