JUDGMENT

(Delivered by G.R.SWAMINATHAN, J.)

Heard both sides.

2. This writ appeal has been filed against the interim order dated 30.04.2024.

3. The first respondent/ writ petitioner has been permitted to continue on duty from 01.06.2024 without getting any salary. She would get salary and other benefits only in the event of her succeeding in the main writ petition.

4. We are of the view that this order does not really affect the appellants' rights. Of course, learned counsel for the appellants has raised certain technical arguments. We are of the view that all these aspects could be decided in the main writ petition.
