ORDER

The death certificate and legal heir certificate of V.Subramanian were marked as Exs.P1 & P2. The documents relating to the share certificates were marked as Exs.P3 to P5.

Taking into consideration the nature of the evidence recorded and the documents produced, this Original Petition stands allowed. and the Succession Certificate shall be issued in favour of the first petitioner, with power to collect the securities and to receive the interest and dividends thereon and negotiate and transfer the securities specified in the Schedule hereunder on payment of appropriate succession duty, if not paid earlier.
