3 The petitioner now undertakes to carry out the demolition plan by adhering to the highest standards of safety. The petitioner, in fact, has addressed a representation in this regard on 07.02.2024 and her grievance is that till date, it has not been considered.

4 After going through the relevant materials enclosed in the typed set of papers, after hearing the learned counsel for the petitioner and also in view of the aforesaid undertaking now given by the petitioner, I am satisfied that the relief sought by the petitioner has to be granted.
