The prayer in the writ petition is for forbearing the fifth respondent from constructing the new bus shelter in Southern Side of the petitioner's land situated at Old S.No.5B/4, New S.No.5B/4E, Budur Village, Maduranthakam Tk., Chengalpattu District.

2.The learned Additional Government Pleader produced photographs which indicate that the construction of the bus shelter is almost 80% complete. Hence, directing demolition at this stage cannot be appropriate. It is open to the petitioner to work out the
