The order of interim stay granted by this Court on 30.05.2024 is extended for a period of two weeks from the date of receipt of a copy of this order, so as to enable the petitioner to approach the Wakf Tribunal.

4.The writ petition is disposed of on the above terms. No costs. Consequently, the connected miscellaneous petitions are closed.
