2. This writ petition has been filed for issuance of a writ of Mandamus to direct the respondents 1 to 4 to take necessary action and remove the encroachment in Kamaraj Street, Rajiv Gandhi Nagar, Chennai-600 118, based upon the petitioner's representation dated 10.05.2024.

3. Heard both sides.

4. Learned Standing Counsel appearing for respondents 1 to 3 – Greater Chennai Corporation submitted that the Stop Work Notice has been
