04.04.2024 to de-occupy 4th, 5th and 6th respondents and to seal the deviated premises belonging to the 3rd respondent i.e., Door No.27/1, Elango Nagar Main Road, Virugambakkam, Chennai – 600 092.

2. Mr.D.B.R.Prabhu, learned Standing Counsel, who accepts notice for respondents 1 and 2 sought three weeks time to take appropriate action in accordance with law.

3. The learned counsel appearing for the petitioner submitted that inadvertently notice has been issued to petitioner's address i.e., Door No.27/2, Elango Nagar Main Road, Virugambakkam, Chennai – 600 092 instead of Door No.27/1, Elango Nagar Main Road, Virugambakkam, Chennai – 600 092. In this regard, the petitioner has also given a representation dated 02.05.2024 to the authority concerned.
