2. Heard learned counsel on either side.

3. Learned Standing Counsel appearing for the Greater Chennai Corporation submitted that petitioner's representation dated 19.04.2024 will be considered by the

Vending Committee under the relevant Act. Learned counsel further submitted that the Vending Committee has been re-constituted and the application of the petitioner will be considered in due course.

In view of the submission made by the learned Standing Counsel, the petitioner's request for certificate of vending shall be considered by the Vending Committee within a period of four weeks from the date of receipt of a copy of this order. Till final orders are passed, status quo as on today shall be maintained by the respondents.

5. The Writ petition stands disposed of accordingly. No costs.
