In view of the specific bar under Section 18 of the Scheduled Castes and Scheduled Tribes (Prevention of Atrocities) Act, 1989 and also taking into consideration of the possibility of misusing the pious intention of the Parliament against innocent persons, there shall be a direction to learned Special Court for SC/ST, Villupuram, to consider the petitioners' bail applications, preferably on the same day of their surrender in connection with Crime No.224 of 2024 on the file of the respondent and pass

appropriate orders in accordance with law, after affording due opportunity to the victim under Section 15-A of the SC/ST (POA) Act, 1989. The petitioners shall surrender before the concerned Jurisdictional Court, within a period of two weeks from the date of the receipt of a copy of this Order.

3. In view of the above, the Criminal Original Petition stands disposed of. No costs.
