(3)The petitioner, on the basis of his representation, has filed the present writ petition. A mandamus can be issued only to enforce a statutory obligation against an authority. In this case, the petitioner has neither indicated any statutory obligation nor the right based on any statute or principle. The writ petition, therefore cannot be entertained. Hence, the writ petition stands **dismissed**.

(4)However, this Court has not gone into the merits of the contentions of the petitioner in this writ petition as she has made serious allegations against the officials of the Bank. It is open to the petitioner to approach any other Forum which can go into the complaint as against the respondent / Bank and can also initiate criminal prosecution as against the Bank if she is able to prove the allegations made against the respondent / Bank or any officials of the respondent / Bank.
