The learned counsel for the petitioner submitted that the petitioner is being enquired under Section 7(A) of the Employees' Provident Funds and Miscellaneous Provisions Act, 1952 (hereinafter referred to as 'the Act' for short) for determining the Employees' Provident Fund dues, if any, payable by the petitioner.



5. In view of the above-stated observations, this Writ Petition is disposed of. The first respondent is directed to consider the representation of the petitioner dated 21.05.2024 and pass orders in accordance with law and on its own merits, within a period of two weeks from the date of receipt of a copy of this order.
