ORDER

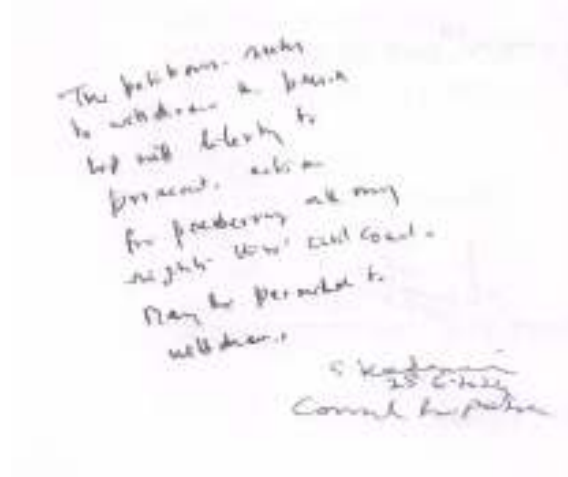
(Order of the Court was made by **M.Sundar, J.**)
