3. The petitioner has sought a mandamus directing R1 to dispose her representation dated 20.02.2024. The plea therein is for cancellation of the name of R3 and inclusion of the petitioner's name as the holder of electricity connection bearing No.589008283 (subject electricity connection).

4. A reading of the writ affidavit reveals several facts which would be better assimilated and appreciated by the authorities. Hence and seeing as the learned Standing Counsel for official respondents accedes to the receipt of representation dated 20.02.2024, mandamus is
