WEB COPY This writ petition is filed for a direction to the respondent authorities to issue computerised patta for the land in Survey No.536/4 to an extent of about 1.85 acres in Siruvachu South Village, Thalaivasal Taluk, Salem District by disposing of the petitioner's representation dated 15.04.2024.

2. The petitioner submitted a representation on 15.04.2024 with a request for issuance of computer patta, however, the same is pending without consideration. Hence, this writ petition.

3. Heard learned counsel for the petitioner and the learned Additional Government Pleader appearing for the respondents and perused the materials available on record.

4. By consent of both parties, this writ petition is taken up for final disposal at the admission stage itself.

5. Considering the limited relief sought for in this writ petition, this Court without going into the merits of the case directs the petitioner to submit an online application for issuance of computer patta within a period of one

week and on such application, the third respondent is directed to consider the application and pass appropriate orders on merits and in accordance with law, after giving notice to any other interested persons. Such exercise shall be completed within a period of two months from the date of receipt of copy of this order.
