2. The petitioner submitted a representation on 16.05.2024 with a request for issuance of patta, however, the same is pending without consideration till date. Hence, this writ petition.

3. Heard learned counsel for the petitioner and the learned Additional Government Pleader appearing for the respondents and perused the materials available on record.

4. By consent of both parties, this writ petition is taken up for final disposal at the admission stage itself.

5. Considering the limited relief sought for in this writ petition, the third respondent is directed to consider the representation of the petitioner dated
