JUDGMENT

The appeal has been filed seeking to quash the order in EC.No.152/2015 dated 06.07.2020 on the file of the Commissioner for Workmen Compensation, Conoor and the award amount of Rs.3,19,880/- (Rupees Three Lakhs Nineteen Thousand and eight hundred and eighty only) in EC. No.152/2015 and thereby allow the civil miscellaneous appeal.

Today, when the matter is taken up for hearing, the learned counsel for the appellant submitted that the entire award amount along with interest has been deposited before the tribunal into the credit in EC.No.152/2015.
