The petitioner, who is working as Driver-cum-Conductor, is imposed with the punishment of increment cut for a period of three years with cumulative effect by the order dated 09.04.2024. 2. Since the appeal, which is preferred as per the Rules, is pending before the third respondent, this writ petition is disposed of on the following terms:

(i) the third respondent is directed to consider the appeal filed by the petitioner dated 07.05.2024, on its own merits and in accordance with law, and pass final orders thereon as expeditiously as possible, in any event not later than a period of eight weeks from the date of a receipt of a copy of this order.

There shall be no order as to costs. Consequently, W.M.P.No.16405 of 2024 is closed.
