4. The learned Additional Government Pleader for the respondents 1 and 2 submitted that the matter is under consideration. In the counter filed by the second respondent, it is stated as under:

"9. It is submitted that the second respondent i.e., Director of Technical Education in his letter No.L.Dis.22183/C1/2019 dated 20.11.2019 has informed that the guidelines for the G.O.Ms.No.303, Higher Education (C1) Department dated 12.12.2018 are under consideration and after issue of the guidelines from the second respondent i.e., Director of Technical Education new proposals for promotion to the post of Workshop Instructors, may be re-submitted for the 2nd respondent for consideration."
