(Order of the Court was made by the Hon'ble Anita Sumanth J.)

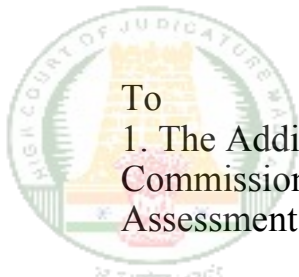
