This Writ Petition is filed to direct the respondents 2 to 4 to survey and demarcate the petitioners' lands comprised in Survey No.400/2B situated at Tirupattur District, Vaniyambadi Taluk, Peddur Village, by considering the petitioner's online E-Challan No.2024/0123/36/000709, dated 25.04.2024.

3. Heard the learned counsel for the petitioner and the learned Special Government Pleader for the respondents 1 to 4 and perused the materials available on record.

4. The grievance of the petitioner is that he has paid the requisite fees to survey the property in Survey No.400/2B situated at Tirupattur



District, Vaniyambadi Taluk, Peddur Village, and demarcate its boundaries.

However, the same has not been considered by the respondents 2 to 4.
