5. Mr.A.Selvendran, learned Special Government Pleader for the respondents submitted that in view of the pendency of the suit under Rule 4(4) of the Tamil Nadu Patta Pass Book Rules, 1987, the revenue records will not be changed till the disposal of the suit. The said submission is recorded.
