ORDER

The petitioner has filed this writ petition seeking issuance of a writ of mandamus directing respondents 1 and 4 to remove the encroachment made in the pathway bearing Survey No.144, Asia Nagar Housing Sites, Kattur Village, Elavangudi, Tiruvarur Taluk and District, on the basis of the petitioner's representation dated 11.5.2024.

2. Mr.Habeeb Rahman, learned Government Advocate, who accepts notice on behalf of respondents 1 to 3, on instructions, submitted that the land in question would be surveyed and, if any encroachment is found, the same would be removed after following

the due process of law.

3. Recording the submission made by learned Government Advocate, the writ petition is disposed of by directing the respondent authorities to survey the land in question within a period of two weeks from the date of receipt of a copy of this order and, upon survey, if any encroachment is found, the same shall be removed in accordance with law, within a period of eight weeks thereafter, of course after issuing notice to all concerned, including the private respondent. There shall be no order as to costs.
