Senior Counsel appearing for the petitioner, by placing on record the proceedings of the sixth respondent dated 15.07.2024, submitted that the sixth respondent has directed the District Collector to shift the TASMAC Shop No.8946 to a different location.

2. Learned State Government Pleader submits that necessary orders for shifting the shop shall be passed by the second respondent/ District Collector at the earliest.

3. As the respondent authorities have already initiated action for shifting of the TASMAC shop, the writ petition is disposed of with a direction to the second respondent/District Collector to shift the TASMAC shop in question within a period of two months from the date of receipt of a copy of this order. There shall be no order as to costs.
