Learned Standing Counsel for the second respondent submits that in pursuant to the notification dated 17.04.2018 issued by the second respondent, the entire selection process has been completed by 16.10.2018 itself and he placed a list of selected candidates before this Court. It is placed on record. Learned counsel also submitted that all the selected candidates have already joined into service, and at this stage, interference of this Court is not required.

Considering the submissions of the learned Standing Counsel for the second respondent and on perusal of the provisional list of selection dated 16.10.2018, this Court is of the opinion that, as selection process has already been completed, at this stage, interference of this Court is unwarranted.
