The writ petition is disposed of accordingly, with a direction to the respondent authorities to consider the representation of the petitioner dated 21.2.2024 and pass appropriate orders on merits and in accordance with law, of course after affording an opportunity of hearing to all the parties concerned, within a period of six weeks from the date of receipt of a copy of this order. There shall be no order as to costs.
