ORDER

This writ petition is filed for a direction to the the 2nd respondent to survey the property in S.Nos.139/10, 139/11, 139/1A, 139/1B, 139/2, 139/3, 139/4, 139/8 an extent of 4 acres at Kanjanaickenpatti Village, Kadayampatti Taluk, Salem District, by disposing of the petitioner's representation dated 29.10.2019, within the time stipulated by this Court.

2. Heard the learned counsel for the petitioner and the learned Special Government Pleader appearing for the respondents and perused the materials available on record.

3. It is the grievance of the petitioner that his application dated 29.10.2019 submitted to the 2nd respondent to survey the subject properties, demarcate its boundaries and also paid necessary fees, has not been considered till date. Hence, the present Writ Petition.

With the above direction, this writ petition is disposed of. No costs.
