## **ORDER**

This petition is filed to seeking to issue a writ of Mandamus directing the Respondent herein to receive the application of the petitioner dated 03.06.2024 in Form CCPA along with the prescribed fee through online for the grant of Auto rickshaw permit to operate the vehicle within radius of 30 k.m distance from Attur Bus stand, Attur, Salem and to consider the same and pass orders.

2.The facts of the case is that the petitioner is a auto rickshaw driver and he has applied for permit through online for the grant of the auto rickshaw permit to operate the vehicle within 30 k.m radius distance from Attur Bus stand, Attur, Salem. It was to the shock and surprise to the petitioner that the respondent herein has refused to grant permit and when the same was questioned by the petitioner the respondent orally informed that they have received instructions from the office of the Transport Commissioner, State Transport Authority, Chepauk, Chennai-5 not to grant any fresh permits for Auto rickshaws. Aggrieved over the same, the present petition has been filed before this Court seeking for

appropriate orders.

3. The learned counsel for the petitioner submitted that the respondent are refusing to receive the application, due to which the petitioner was put to great serious inconvenience and hardship. Hence, prays to allow this petition.

4.The learned Special Government Pleader appearing for the Respondent submitted they will consider the case of the petitioner and take action in the manner known to law.

5. For the foregoing reasons this Court directs the respondent to receive the application of the petitioner dated 03.06.2024 in Form CCPA along with the prescribed fee for grant of Auto Rickshaw permit and consider the same on its own merits and in accordance with law and pass orders within period of six weeks from the date of receipt of a copy of this order.

6. With the aforesaid direction, this writ petition is disposed of. No
