This Writ Petition has been filed seeking ordinary leave for the petitioner's brother viz., Vengadesan, S/o.Chinnaraji, aged about 42 years, bearing confined at Central Prison, Puzhal, for a period of one month.

2. Learned Additional Public Prosecutor submitted that the petitioner was released on emergency leave, without escort on 28.07.2012 for 3 days and he was supposed to return on 01.08.2012, but he failed to do so and had absconded and could be recaptured only after 10 years on 10.10.2022.
