This writ petition is filed for a direction to the 3rd respondent to consider the representation dated 20.03.2024 and to issue the patta in the name of the petitioner in respect of the lands comprised in Survey No.555 of Ayaranapalli Village, Shoolagiri Taluk, Krishnagiri District of an extent of Hec. 1.00.5 (or) Ac 2.49 cents.

2. The petitioner submitted a representation on 20.03.2024 with a request for issuance of patta, which is pending without consideration. Hence, this writ petition.

3. Heard learned counsel for the petitioner and the learned Special Government Pleader appearing for the respondents and perused the materials available on record.

4. By consent of both parties, this writ petition is taken up for final disposal at the admission stage itself.

5. Considering the limited relief sought for in this writ petition, the third respondent is directed to consider the representation of the petitioner dated 20.03.2024 and pass appropriate orders on the petitioner's representation on merits and in accordance with law, after giving notice to the neighbouring land
