ORDER

The petitioner herein given a representation to the respondent police on 22.01.2024 to delete his name from the list of History Sheeter vide H.S.No.351 of 2013.

2. The learned Government Advocate (Crl.Side) submits that 11 criminal cases are pending against this petitioner. The last case was registered on 28.05.2024 in Cr.No.254 of 2024 by Tusi Police Station, Thiruvannamalai District for offences under Section 379, 430 IPC and 21(1) of Mines and Minerals Act. 3. In the light of the fact indicating that the petitioner is a habitual offender and had been continuously committing offence which has brought to the adverse notice of the police, there is no reason to direct the respondent police to delete her name from the history sheet.
