3. Heard the learned counsel for the petitioner, learned Special Government Pleader for the respondent and perused the materials available on record.

4. The grievance of the petitioner is that he has given application dated 19.10.2023 to survey the property and demarcate its boundaries in Survey No.58/4B situated at Siyamangalam Village, Ulundurpet Taluk, Kallakurichi District. However, the same has not been considered by the respondent.
