This Writ Petition is filed to direct the respondents to survey the petitioner's lands comprised in Survey No.518/3B measuring an extent of 1.17 acres, situated at Periyeri, Thuringikuppam Village, Polur Taluk, Tiruvanamalai District, by considering the petitioner's representations dated 22.09.2022 and 06.02.2024.

3. Heard the learned counsel for the petitioner and the learned Special Government Pleader for the respondents and perused the materials available on record.

4. The grievance of the petitioner is that he has given representations dated 22.09.2022 and 06.02.2024 to survey the property in Survey No.518/3B situated at Periyeri, Thuringikuppam Village, Polur Taluk, Tiruvanamalai District. However, the same had not been considered by the respondents.

Considering the limited nature of the relief sought for in the present Writ Petition, there shall be a direction to the respondents to consider the petitioner's representations dated 22.09.2022 and 06.02.2024 and pass appropriate orders, for survey of the property, after giving notice to the neighbouring land owners and any other interested persons, within a period of two months from the date of receipt of a copy of this order.
